C) Agricultural Heritage:

The community grant fund seeks to help open up a more prosperous future for Blissfield through understanding and appreciation of its deep historical roots in the agriculture industry. We encourage programs that aim to help foster a greater connection to the earth, food security and celebrating local history.

D) Environmental Sustainability:

We have interest in supporting programs that offer a strong connection to environmental revitalization, sustainability, or education.
